the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. ODELL SHAVER, HIS HEIRS AND ASSIGNS:

ALL the certain piece, parcel or lot of land in Austin Township, Greenville, County, State of South Carolina, within the corporate limits of the City of Maulding, and being known and designated as Lot Number 124 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:
