All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 114 as shown on a plat of Property of W. J. Greer prepared by C. F. Webb, R.L.S., February 1960, recorded in the R.M.C. Office for Greenville County in Plat Book OO, at Page 489, and having, according to said plat, the following metes and bounds, to-wit:
