in consideration of Seven Thousand, Five Hundred and no/100 - - - - - (\$7,500.00) - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto W. C. Bumby, his heirs and assigns forever:

All those pieces, parcel or lots of land, situate, lying and being in the State of South Carolina, County of Greenville, north of the City of Greenville, being known and designated as Lots 30 and 31 of a subdivision known as Sans Souci Park as shown on plat prepared by A. F. Bedell and revised by C. M. Furman, Jr. being recorded in the R. M. C. Office for Greenville County in Plat Book C, at Page 158 and having, in the aggregate according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Davis Street, joint front corner of Lots 31 and 32 and running thence along joint line of said lots, S. 55-54 E. 125 feet to an iron pin; thence S. 33-51 W. 102 feet to an iron pin on the northern side of Davis Street; thence with said street, N. 46-50 W. 98 feet to an iron pin; thence continuing with said street, N. 17-45 E. 93 feet to the beginning corner; being the same property conveyed to me by two deeds, one from M. E. Tyus dated April 8, 1949 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 379 at Page 17 and the other from F. G. Harkins dated June 10, 1946 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 292, at Page 447.
