H. Morgan, his heirs and assigns forever:

All that certain lot of land lying in Greenville County, State of south Carolina on the Eastern side of Willow Springs Drive shown as Lot No. 30 of Section 2 on a plat of Pleasant View recorded in the R. M. C. Office for Greenville County in Plat Book HH at Page 152 and being further described according to said plat as follows:
