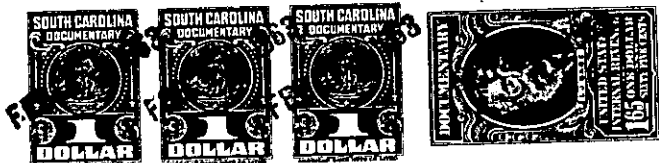
KNOW ALL MEN BY THESE PRESENTS, that I, Florrie V. Greer
