All that piece, parcel or strip of land situate, lying and being in Greenville County, South Carolina and being a portion of Lot 29 as shown on Plat of Western Hills, recorded in the RMC Office for Greenville County in Plat Book QQ, Pages 98-9 and having the following metes and bounds, to-wit:
