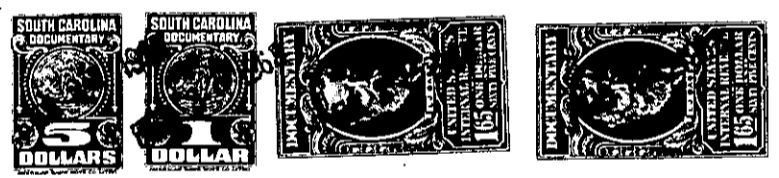
in consideration of Twenty Eight Hundred Two and 50/100-----(\$2802.50)-----Dollars,
