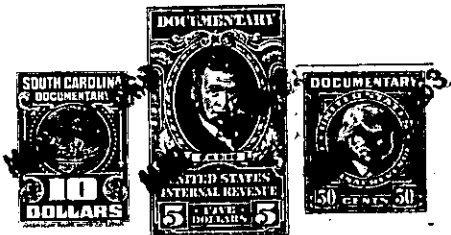

Marion B. Uldrick, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as lot #26 of a subdivision known as "ADDITION TO WILDAIRE ESTATES", according to a plat thereof prepared by Piedmont Engineering Service, November 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book RR, at page 100, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of lots #25 and #26 on the northern side of Wildaire Lane, and running thence along the joint line of these lots, N. 24-40 W. 86.2 feet to an iron pin in the property line; running thence N. 84-59 W. 179.1 feet to an iron pin on the eastern side of Briarwood Blvd.; thence along the eastern edge of Briarwood Blvd., S. 8-03 E. 105.0 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 53-38 E. 34.9 feet to an iron pin on the northern side of Wildaire Lane; running thence along the northern edge of Wildaire Lane N. 80-47 E. 99.2 feet to an iron pin; thence continuing along said Lane, N. 78-38 E. 75.0 feet to an iron pin, point of beginning.
