to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Calvin Kellett, his heirs and assigns forever:

ALL that certain piece, parcel or tract of land, situate, lying and being in Greenville County, State of South Carolina, in Fairview Township, near the Town of Simpsonville, containing 18.4 acres, more or less, in accordance with plat made for Mrs. J. T. Leopard, dated April 8, 1959, by R. B. Bruce, and having, according to said plat, the following metes and bounds, to-wit:
