the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

Roy W. Boggess and E. H. Price, their heirs and assigns:

All that certain lot of land situate, lying and being on the western side of Orchard Drive, near the City of Greenville, State of South Carolina, being known and designated as Lot #205, as shown on a plat prepared by J. Mac Richardson, R.L.S., dated February 1961, entitled, "FINAL PLAT - SECTION 3, ORCHARD ACRES", and recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Orchard Drive, the joint front corner of lots #205 and #206, and running thence along the joint line of these lots, S. 84-30 W. 160 feet to an iron pin in the line of lot #204; thence S. 1-59 W. 114.2 feet to an iron pin on the northern side of Hartsville Street; running thence along the northern edge of Hartsville Street, N. 86-39 E. 150 feet to an iron pin at an intersection, which intersection is curved, the chord of which is N. 40-56 E. 35.6 feet to an iron pin on the western side of Orchard Drive; thence along the western edge of Orchard Drive, N. 5-30 W. 95 feet to an iron pin, point of beginning.
