All of my one fourth (1/4) undivided interest in and to all that portion of land consisting of two (2) tracts, situate, lying and being in the State and County aforesaid, Oneal Township, about 3 miles northwest of Greer, S. C., the first tract being shown as tract No. 5 on Plat of Property of B. L. Smith Estate made by H. S. Brockman, Surveyor, December 16th 1949, and having the following courses and distances, to wit:-

BEGINNING on a stake and old stone, joint corner of the Perry Smith Estate lands and runs thence N. 4-00 E. 132 feet to a stake, joint corner of tracts 3 and 4 as shown on said plat; thence N. 4-00 E. 376.5 feet to an iron pin on the rear line of tract No. 3; thence with the line formerly of Mell Bramlett, N. 84-30 W. 546 feet to a stake on the east side of branch; thence with the former Lee Bramlett line, S. 3-10 W. 465 feet to an iron pin; thence with the Will Bramlett line, S. 10-00 E. 333.5 feet to a stake on east side of branch; thence with the Perry Smith Estate line, N. 64-30 E. 541.2 feet to the beginning corner, containing Seven and Ninety Three One-hundredths (7.93) acres, more or less.

SECOND TRACT being shown as a part of tract No. 2 on Plat of Property of W. H. Smith Estate (that part lying on the west side of the Gilreath Mill Road (State Highway No. 101), said plat made by H. S. Brockman Surveyor, November 30th 1936, and having the following courses and distances, to wit: BEGINNING on a nail and cap in the said highway, joint corner of tracts 2 and 3, and runs thence with the common line of tracts 2 and 3, N. 75-05 W. 1795 feet to a stake on branch, n.m.; thence up the branch, S. 5-05 W. 264 feet to a stake, joint corner of the former John Crain Estate (Subdivided); thence with the common line of the Crain tract and this tract, S. 64-45 E. 1980 feet to an iron pin just west of the said highway; thence with the said highway in a north direction 640 feet, more or less, to the beginning corner, containing Seventeen and Eighty Three One-hundredths (17.83) acres, more or less.
