the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Larry G. Shaw, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #55 on the southern side of Hampshire Drive, of a subdivision known as Homestead Acres, as shown on a plat prepared by J. Mac Richardson, Engineer, dated November 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Hampshire Drive, the joint front corner of lots #54 and #55, and running thence along the line of these lots, S. 2-10 E. 156.1 feet to an iron pin; thence N. 75-43 E. 97.1 feet to an iron pin at the joint rear corner of lots #55 and #56; running thence N. 2-00 W. 135.6 feet to an iron pin on the southern side of Hampshire Drive; thence along the southern side of Hampshire Drive S. 87-50 W. 95 feet to an iron pin, point of beginning.
