McKoy, his neirs and assigns, all my right, title and one-third undivided interest in and to:

All that piece, parcel, or tract of land in Saluda Township, containing 218.75 acres, more or less, and being more particularly described according to survey and Plat of W. H. Hester, April 11, 1934, as follows:
