All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 1 of a subdivision known as "ADDITION TO WILDIRE ESTATES", according to a plat thereof prepared by Piedmont Engineering Service, November 1962, and recorded in the R. BEGINNING at an iron pin on the northern side of Edwards Road, the joint front corner of lots #1 and #2, and running thence along the northern side of Edwards Road S. 84-13 W. 74.1 feet to an iron pin at an intersection, which intersection is curved, the chord of which is N. 51-55 W. 36.0 feet to an iron pin on the eastern side of Briarwood Blvd.; thence along the eastern side of Briarwood Blvd., N. 8-03 W. 155.0 feet to an iron pin at the joint front corner of lots #1 and #5; running thence N. 77-16 E. 106.5 feet to an iron pin at the joint rear corner of lots #1 and #2; thence S. 5-47 E. 192.5 feet to an iron pin, point of beginning.
