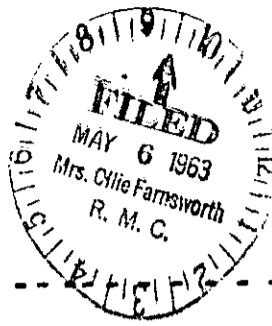

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
Caroline Elizabeth Fore, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lots Nos. 76 and 90 as shown on a plat of Valencia Estates by W. N. Willis, Engineers, dated November 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 179 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Seville Street, joint front corners of Lots nos. 75 and 76 and running thence along the line of said lots, N. 85-28 W. 214.9 feet to iron pin rear corner of Lots 89 and 90; thence running with line of said lots, N. 85-28 W. 386.7 feet to iron pin on Grenada Street; thence running with Grenada Street, N. 4-48 E. 90 feet to iron pin front corner of Lot 91; thence running with said lot, S. 85-28 E. 319.2 feet to iron pin rear corner of Lots 76 and 77; thence running with line of said lots, S. 85-28 E. 282 feet to iron pin on Seville Street; thence running with said street, S. 4-32 W. 90 feet to iron pin point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only,

THIS conveyance is subject to all easements and rights of way of record.
