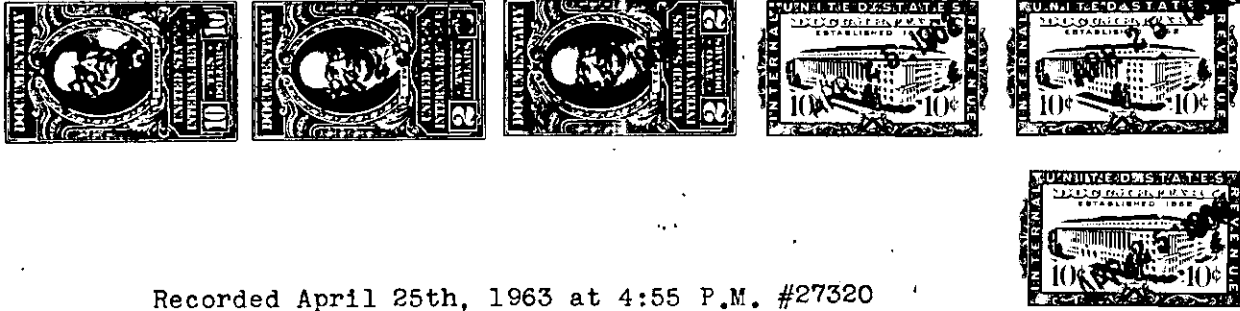


DESCRIPTION CONTINUED:

BEGINNING at an iron pin on the northeast side of Elizabeth Drive, at the joint corner of Lots Nos. 100 and 213 and running thence with the line of Lot 213 N. 72-52 E. 200 feet to an iron pin; thence N. 33-31 W. 25 feet to an iron pin in line of other property of W.
