All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, Grove Township, as is shown on a plat of property containing 1.54 acres, being a portion of Mrs. E. A. Cason Property according to plat prepared by J. A. Pickens, September 16, 1944 and recorded in the R.M.C. Office for Greenville County in Plat Book at Page and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a hickory, the old property corner, and running thence along the line of property formerly of C. V. Verner, N. 54 - 1/4 E. 311 feet to a stake at the corner of property formerly owned by C. N. Pittman; running thence along a line through the tract containing 1.54 acres approximately S. 21-1/2 E.239.8 feet to a pin in the center of a county road which is now known as Osteen Road and running thence along the center of said road, S. 79 W. 311 feet to a point located .20 links from the hickory tree, the point of beginning. This property is located on the northern side of a county road now known as Osteen Road.
