KNOW ALL MEN BY THESE PRESENTS, that we, George H. Lindsey, Albert P. Jones and Alvin E. Smith,

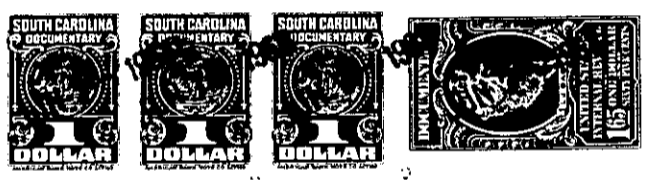
in consideration of One Thousand Four Hundred Ninety-Five and no/100 Dollars,
