Know All Men by These Presents:

That We, H. Norwood Forrest & Pauline H. Forrest

in consideration of the sum of \$1.00 and the premises. in the State aforesaid,  
DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Arthur William Taylor, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 27 on a plat of Grand View Heights recorded in the RMC Office for Greenville County in Plat Book EE at Page 199 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Grand View Circle at the joint front corner of Lots 27 & 28 and running thence with the common line of said lots S. 86-45 W. 200 feet to an iron pin; thence S. 3-15 E. 100 feet to an iron pin; thence N. 86-45 E. 200 feet to an iron pin on the western side of Grand View Circle; thence with said Circle N. 3-15 W. 100 feet to the point of beginning.

On November 17, 1960, Homer Styles conveyed Lots 27 & 28 of the above subdivision to H. Norwood Forrest and Pauline H. Forrest as will be shown by deed recorded in Deed Book 664, Page 216. It was the intention of these parties that Lots 21 & 22 be conveyed and, H. Norwood Forrest and Pauline H. Forrest subsequently attempted to reconvey to Homer Styles the said lots 27 & 28 as will be shown by deed recorded in Deed Book 677, Page 422. However, Pauline H. Forrest neglected to join in this deed with her husband and the Probate on this particular deed is defective. On June 27, 1962, Homer Styles conveyed to Arthur William Taylor Lot 27 of the above subdivision and this deed apparently only conveys the one-half interest in said lot.

This deed is now being executed by H. Norwood Forrest and Pauline H. Forrest so as to cure any defect in the title and to vest in Arthur William Taylor the entire fee simple title to the lot.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
