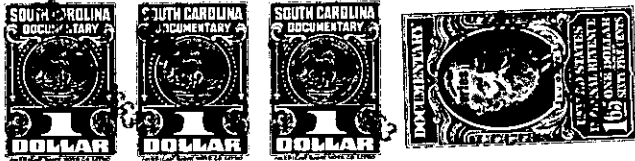
KNOW ALL MEN BY THESE PRESENTS, that I, Florrie E. Greer

unto William O. Bryant

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, being known and designated as lot No. 127 in the subdivision known as Eastdale Development, plat of said subdivision being recorded in the Greenville County R. M. C. Office and being more fully described as follows:

BEGINNING at an iron pin on the south side of Birchwood Lane, joint corner with lot No. 126, and running thence along said lot S. 22-37 W. 175.2 feet to an iron pin; thence S. 68-53 E. 104.1 feet to an iron pin; thence N. 21-17 E. 172.5 feet to iron pin on Birchwood Lane; thence along Birchwood Lane N. 67-23 W. 100 feet to the beginning corner, and being a portion of the same lands conveyed to B. E. Greer by S. H. Brooks by deed recorded in the R. M. C. Office for Greenville County in Deed Book 51 at page 35, and this conveyance is here made by Florrie E. Greer in accord with the Will of the said B. E. Greer, deceased, will on file in the Office of the Probate Judge for Greenville County in File 633, Apt. 38.

Grantor herein hereby reserves an easement of 5 feet for drainage over and across said lot, said 5 foot strip lying along western line and running the entire length of lot adjoining lot No. 126 as shown on the above mentioned recorded plat.
