All that piece, parcel and strip of land situate, lying and being on the eastern side of the Staunton Bridge Road, Gantt Township, County of Greenville, State of South Carolina, and having according to a plat "Proposed widening ten-foot road, Greenville County, South Carolina", prepared by Dalton & Neves, Engineers, June 1963, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of the Staunton Bridge Road in the center of the intersecting existing unnamed ten-foot road and running thence with the center line of the existing unnamed ten-foot road S. 71-15 E. 144.0 feet to an iron pin; thence S. 18-45 W. 5 feet to an iron pin; thence S. 81-45 W. 21.7 feet to an iron pin; thence N. 71-15 W. 121.5 feet to an iron pin on the eastern side of the Staunton Bridge Road; thence N. 5-05 E. 15.4 feet to the iron pin at the point of beginning.
