Know All Men by These Presents:

That We, Ira G. Skelton, Aquilla S. Barnett, and Tibatha Skelton, in consideration of the sum of ONE and NO/100-----(\$1.00)-----DOLLARS, and other valuable consideration, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Savilla M. Skelton, her heirs and assigns forever:

All our right, title and interest in and to ALL that certain piece, parcel or lot of land being known and designated as a portion of Lot No. 24 of Section 6 of Judson Mills Village and being situated on E Street and according to a recent survey having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the line of Lot No. 25, said point being 269 feet southwest of the joint front corner of Lots Nos. 25 and 24 and running thence N. 17 W. 70 feet to an iron pin, the joint rear corner of Lots Nos. 23 and 24 in the branch; thence with the branch as the line, S. 37-47 E. 89.2 feet to an iron pin, the joint rear corner of Lots Nos. 25 and 24; thence with the joint line of said lots N. 88-20 E. 56.7 feet to an iron pin, the beginning corner, this being a portion of the property conveyed to Ira G. and Savilla M. Skelton by deed dated June 8, 1954, and recorded in the R. M. C. Office for Greenville County in Volume 501 at Page 118. Ira G. Skelton died October 14, 1960, leaving in force his Last Will and Testament as appears in the Office of the Judge of Probate, Apt. 745, File 7. The consideration of this deed is the same as consideration in deed from Savilla M. Skelton to the School District of Greenville County.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
