A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Sixteen Hundred Ten and no/100----- (\$1610.00)----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto John K. Temple, Jr. his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #3, of a subdivision known as Welcome Acres, as shown on a plat thereof prepared by Piedmont Engineering Service, dated July 1963, recorded in the R. M. C. Office for Greenville County in Plat Book DDD, at Page 44, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Welcome Road, the joint front corner of Lots #3 and #2, and running thence along the line of these lots, N. 39-02 E. 165.5 feet to an iron pin in the rear line of lot #8; running thence along the rear line of lot #8, S. 52-52 E. 76.8 feet to an iron pin at the joint rear corner of lots #7 and #8; running thence S. 52-23 E. 12.9 feet to an iron pin at the joint rear corner of lots #3 and #4; running thence S. 39-00 W. 170.5 feet to an iron pin on the northern side of Welcome Road; thence along the northern side of Welcome Road, N. 49-41 W. 90.0 feet to an iron pin, point of beginning.

This being a portion of that property conveyed to the Grantor Corporation by deed of Thelma L. Lusk and S. H. Lusk, dated January 7, 1963, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 714, at Page 470.
