the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto H. J. Martin and Joe O. Charping, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot #91 of a subdivision known as Wellington Green, as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 29, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Melbourn Lane, the joint front corner of lots #91 and #80, and running thence along the joint line of these lots, N. 28-30 E. 142.5 feet to an iron pin; running thence N. 84-39 E. 51.3 feet to an iron pin at the joint rear corner of lots #91 and #90; running thence S. 5-12 E. 180.2 feet to an iron pin on the northern side of Melbourn Lane; running thence along the northern side of Melbourn Lane, which line is curved, the chord of which is, N. 75-18 W. 85.0 feet to an iron pin; thence continuing along the northern side of Melbourn Lane, N. 62-19 W. 60.0 feet to an iron pin, point of beginning.
