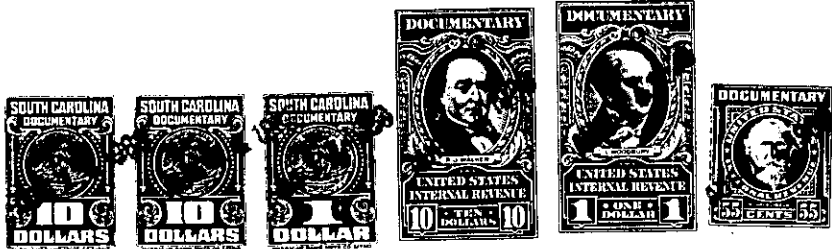
KNOW ALL MEN BY THESE PRESENTS, that W. N. Leslie, Inc.

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto John M. Pitts and Ruby R. Pitts, their heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #16 of a subdivision known as Kentland Park, as shown on a plat thereof, being recorded in the R. M. C. Office for Greenville County in Plat Book XXX, at Pages 44 and 45, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Oak Drive, the joint front corner of lots #16 and #15, and running thence along the line of these lots, N. 36-05 E. 187.3 feet to an iron pin in the rear lot line of lot #8; thence N. 61-38 W. 70.5 feet to an iron pin at the joint rear corner of lots #16 and #17; running thence along the joint line of these lots, S. 36-05 W. 177.8 feet to an iron pin on the northern side of Oak Drive; thence along the northern side of Oak Drive, S. 53-55 W. 70.0 feet to an iron pin, point of beginning.
