in the State aforesaid, R.M.C.

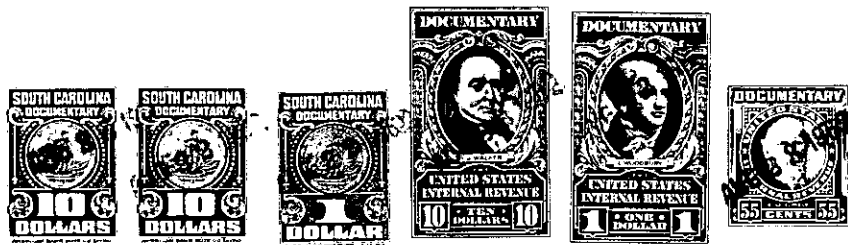
in consideration of the sum of Ten Thousand Three Hundred and no/100 (\$10,300.00) DOLLARS,
