All our undivided rights, titles, and interests in and to,

All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying, and being on the northern side of Henrietta Street, in the City and County of Greenville, South Carolina, which has, according to a plat prepared by Piedmont Engineers and Architects, dated August 5, 1963, the metes, bounds, courses, and distances following:

BEGINNING at a point on the northern side of Henrietta Street, joint corner of the property hereby conveyed and other property of the grantors herein, and running thence N. 0-30 W. 152.7 feet to a point on the southern side of East Park Avenue; thence N. 73-47 W. 470 feet along the southern side of said Avenue to a point, joint corner of property hereby conveyed and property of Schumpert; thence S. 4-36 W. 163.5 feet along the joint line of property hereby conveyed and property of Schumpert to a point; thence S. 10-39 E. 125.85 feet to a point on the northern side of Henrietta Street; thence N. 89-44 E. 444.3 feet along the northern side of Henrietta Street to a point, the point of beginning.
