in consideration of Ten and No/100 (\$10.00) - - - - - Dollars, and other valuable consideration, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Piedmont Engineers and Architects, Inc., its Successors and Assigns,

All our undivided rights, titles, and interests in and to, All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying, and being on the northern side of Henrietta Street, in the City and County of Greenville, South Carolina, which has, according to a plat prepared by Piedmont Engineers and Architects, dated August 5, 1963, the metes, bounds, courses, and distances following:

BEGINNING at a point on the northern side of Henrietta Street, joint corner of the property hereby conveyed and other property of the grantors herein, and running thence N. 0-30 W. 152.7 feet to a point on the southern side of East Park Avenue; thence N. 73-47 W. 470 feet along the southern side of said Avenue to a point, joint corner of property hereby conveyed and property of Schumpert; thence S. 4-36 W. 163.5 feet along the joint line of property hereby conveyed and property of Schumpert to a point; thence S. 10-39 E. 125.85 feet to a point on the northern side of Henrietta Street; thence N. 89-44 E. 444.3 feet along the northern side of Henrietta Street to a point, the point of beginning.

The property hereby conveyed is a portion of the property conveyed by Martha E. Williams to Oliver F. Going, M. S. Fowler, and Sam R. Zimmerman, by deed recorded in Deeds Book 625, Page 536, which property is shown on a plat recorded in Plats Book "L", Page 6. The records of the estate of Sam R.
