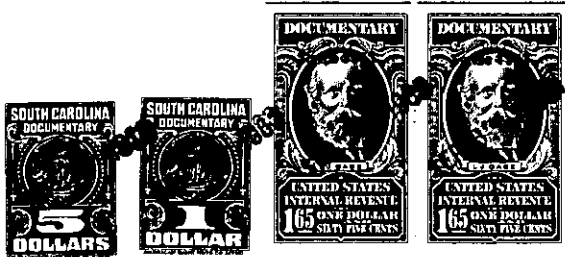

Robert M. Jones and Mary M. E. Jones their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Butler Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #4, of a subdivision known as Laurel Heights, and being more particularly described according to Plat recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 33, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Fairlane Circle, the joint front corner of lots #4 and #5, and running thence along the line of these lots N. 58-11 E. 80 feet to an iron pin at the joint rear corner of lots #3 and #4; running thence along the joint line of these lots N. 31-49 W. 150 feet to an iron pin on the southern side of Henderson Drive; running thence along the southern side of Henderson Drive S. 58-11 W. 55 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 13-11 E. 35.5 feet to an iron pin on the eastern side of Fairlane Circle; thence along the eastern side of Fairlane Circle S. 31-49 E. 125 feet to an iron pin, point of beginning.
