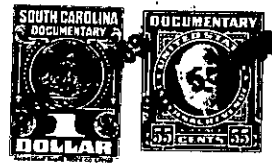
in consideration of the sum of **Five Hundred (\$500.00)** - - - - -

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J.B. Bowers and his heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, State of South Carolina, located about one mile south of the City of Greer and on the northwest side of a new street known as Pleasant Drive and on the southwest side of Leona Avenue, designated as Lot No. 7 on a plat of property made for H. H. Cox by Terry T. Dill, C. E., dated December 13, 1957, recorded in the RMC Office for Greenville County in Plat Book KK, page 149, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the corner of Lot Nos. 6 and 7 on Pleasant Drive, and runs thence with the common line of these lots, N. 43-07 W. 160 feet to an iron pin; thence N. 47-05 E. 85 feet to an iron pin on Leona Avenue; thence therewith S. 48-30 E. 160 feet to an iron pin at corner of said Avenue and Pleasant Drive; thence with the margin of said drive, S. 47-04 W. 100 feet to the beginning corner.

This deed is made subject to restrictive and protective covenants as appear in that instrument dated May 31, 1953, recorded in Deed Book 599, at page 321, RMC Office for Greenville County.
