All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southeastern side of Brushy Creek Road and being known and designated as Lot No. 2 of Terrace Gardens as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", Page 85 and having, according to said plat, the following metes and bounds, to-wit:
