in Office and Assigns Forever:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the northern side of Campbell Street, being known as the eastern portion of Lot No. 2 and a small triangular portion of the western side of Lot No. 1 as shown on a plat of University Circle made by Piedmont Engineering Service, May, 1948, said plat being recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book Y at page 111; and being more specifically shown on a plat made by R. K. Campbell, Engineer, April 29, 1960, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book TT at page 24, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Campbell Street, 283 feet from the intersection of Campbell Street and White Oak Drive, being the joint front corner of Lots Nos. 1 and 2, and running thence N. 12-05 W. 131.8 feet to an iron pin; thence running N. 85-15 W. 85 feet to an iron pin; thence running S. 16-33 E. 150 feet to an iron pin on the northern side of Campbell Street, being the joint front corner of Lots Nos. 2 and 3; thence running N. 83-30 E. 70 feet to an iron pin, being the joint front corner of Lots Nos. 1 and 2, the point of beginning.
