BEGINNING at an iron pin on the northern side of Springbrook Drive, joint corner of the lot herein conveyed and property retained by the grantor and running thence along the line of property retained by the grantor N. 1-43 W. 158.5 feet to a point on the southern side of White HorseRoad Extension, said line crossing an iron pin 11.2 feet back from the southern edge of said White Horse Road Extension; thence along the southern edge of White Horse Road Extension S. 74-17 W. 80.5 feet to a point on the southern edge of White Horse Road Extension; thence S. 0 -38 E. 132 feet crossing an iron pin 11.2 feet south of the southern edge of White Horse Road Extension to an iron pin on the northern edge of S pring brook Drive; thence along the northern edge of Springbrook Drive S. 86-35 E. 80.5 feet to an iron pin, the point of betinning.
