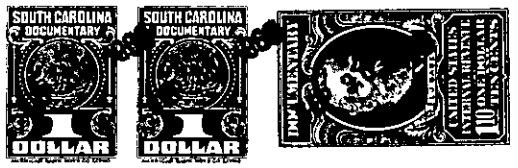

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, just outside the corporate limits of the Town of Fountain Inn, known and designated as Lot No. 12 on a Plat prepared by Lewis C. Godsey, Surveyor, Feb. 9, 1956, entitled "Golden Strip Sub. Div., Frederick W. Wenck, Owner - Approx. 1 1/2 miles North of Fountain Inn, S.
