The right of way is to and does convey to the grantee, its successors and assigns the follor privilege of entering the aforesaid strip of land, and to construct, maintain and operate within the lines, manholes, and any other adjuncts deemed by the grantee to be necessary for the purpose of sewage and industrial wastes, and to make such relocations, changes, renewals, substitutions, replace of or to the same from time to time as said grantee may deem desirable; the right at all times to clear of said pipe lines any and all vegetation that might, in the opinion of the grantee, endange lines or their appurtenances, or interfere with their proper operation or maintenance; the right of if from said strip of land across the land referred to above for the purpose of exercising the rights here that the failure of the grantee to exercise any of the rights herein granted shall not be construed as a ment of the right thereafter at any time and from time to time to exercise any or all of same.
