Know All Men by These Presents:

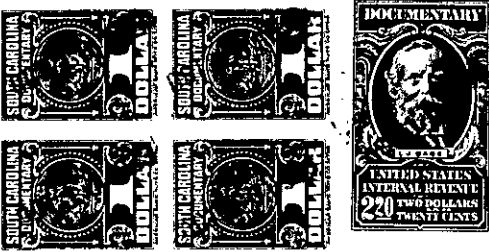

All that piece, parcel or tract of land situate, lying and being in Greenville County, South Carolina and containing 2.02 acres, according to a plat of the property of D. O. Brookshire, prepared by C. O. Riddle, May 1959, which plat is recorded in Plat Book QQ, Page 115 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Buckhorn Road at the joint front corner of the property herein conveyed and a tract owned, now or formerly by W. B.
