Carroll and Ruth W. Carroll, their heirs and assigns forever,

All my remaining one-half interest in and to that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the East side of Elmwood Avenue (formerly Fifth Avenue) being known and designated as Lot No. 50 on plat of Section 2 of Judson Mills Village, made by Dalton & Neves, Engineers, in November 1939, which plat is recorded in Plat Book K at page 25, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of Elmwood Avenue and Fifth Street, and running thence with the South side of Fifth Street, S. 83-53 E. 123.3 feet to an ironpin on said street; thence with the rear line of Lot 49, N. 83-53 W. 123.3 feet to an iron pin on the East side of Elmwood Avenue; thence with the East side of Elmwood Avenue, N. 6-07 E. 80 feet to the Beginning corner. Being the same property conveyed to the Grantor by Lee Weeks by deed recorded in Deed Book 297 at page 98.

As a part of the consideration for this deed the Grantees assume and agree to pay the balance due on a mortgage held by Fidelity Federal Savings & Loan Assn. , the principal balance of which is \$3,033.01.

The Grantor bythe execution of this deed reserves the right to occupy said premises as a home for herself at any time during her life as she so elects.
