ALL that lot of land with the improvements thereon situate, lying and being on the West side of Augusta Street in the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 10 and a strip lying South of and adjacent thereto as shown on plat of Property of S. O. Skelton made by R. E. Dalton, Engineer, August 1919, recorded in the RMC Office for Greenville County, S. C. in Plat Book E, at page 282, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Augusta Street, said pin being 160 feet North from the Northwest corner of the intersection of Augusta Street and McKay Street, and running thence along the West side of Augusta Street, N. 17-0 W., 61.5 feet to an iron pin; thence S. 83-51 W., 191 feet to an iron pin; thence S. 2-23 W., 34 feet to an iron pin; thence S. 88-47 E., 46 feet to an iron pin; thence S. 3-32 E., 9.2 feet to an iron pin; thence N. 87-58 E., 162.4 feet to the beginning corner on the West side of Augusta Street.
