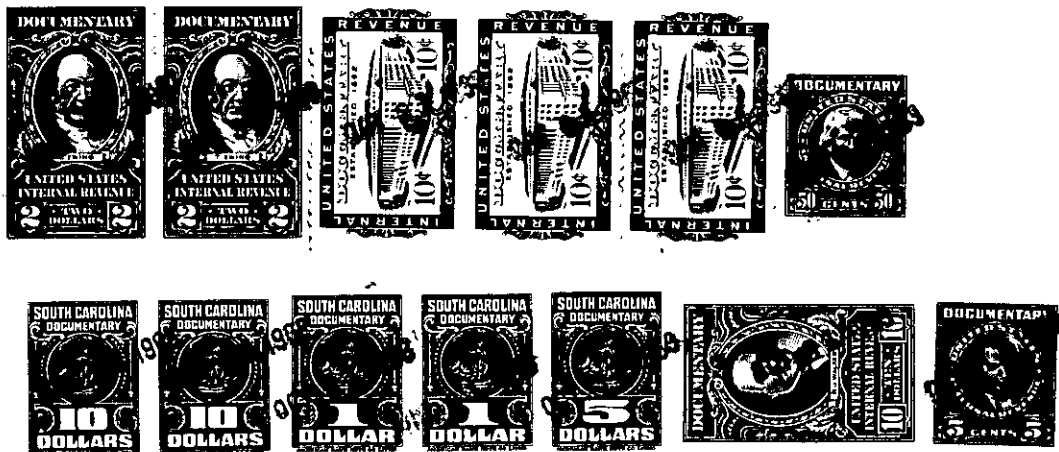
KNOW ALL MEN BY THESE PRESENTS, that we, Herbert E. Rudd and Jack E. Shaw
