the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edgar L. Johnson, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, located on the south side of the Old Spartanburg Road, and being designated as the eastern portion of a tract of land as shown on a plat of property of J. R. Rodgers, recorded in the R. M. C. Office for Greenville County in Plat Book B at Page 137, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Old Spartanburg Road in the line of land now or formerly owned by Gibson and running thence S. 30 E. 740 feet to an iron pin; running thence still with the line of land now or formerly owned by Gibson due south crossing a branch 150 feet to an iron pin; thence N. 30 W. 875 feet to a point in the center of said road; running thence with the center of said road, N. 64 E. 75 feet to the point of beginning; being the same conveyed to us by Robert Lee Sherill by deed dated March 5, 1955 and recorded in the R.
