and effect except as to the rights and easements hereby expressly released.

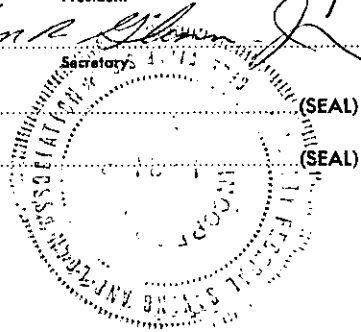
