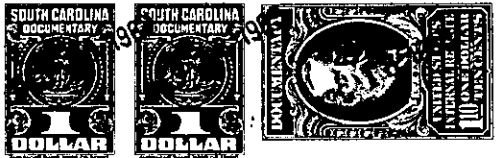
KNOW ALL MEN BY THESE PRESENTS, that HUGUENIN & DOUGLAS INC.
