KNOW ALL MEN BY THESE PRESENTS, that I, Lloyd W. Gilstrap,

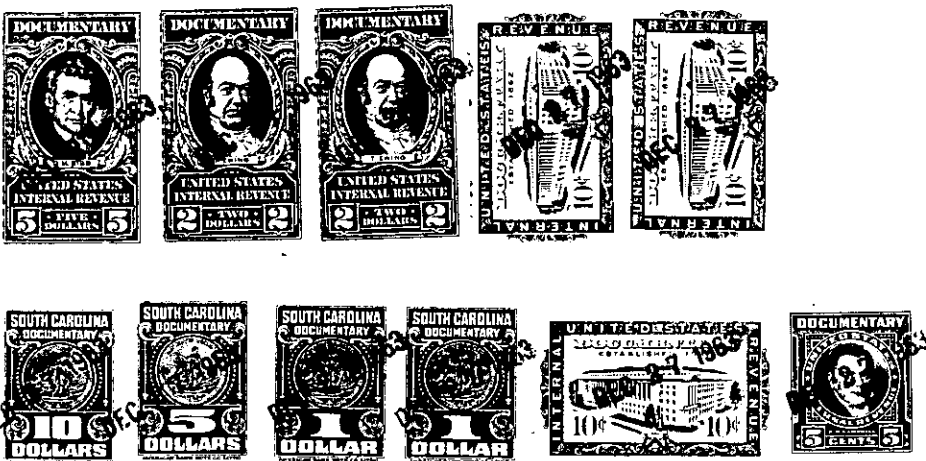
in consideration of Eighty Three Hundred Fifty and No/100----- Dollars,
