That I, John R. Stewart,

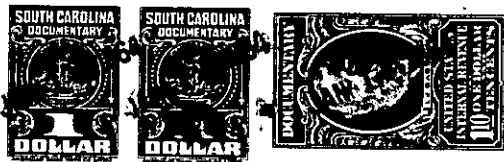
in consideration of the sum of Seven Hundred and Fifty (\$750.00) - - - - - in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Alma Jean Wolfe and her heirs and assigns forever:

All that certain parcel or lot of land situated on the east side of Earle Street in the City of Greer, Chick Springs Township of Greenville County, State of South Carolina, and being the northern one-half portion of Lot No. 2 of PLEASANT VIEW ACRES, plat thereof recorded in Plat Book FF, page 365, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the east side of Earle Street, corner of Lots Nos. 2 and 3, and running thence along the line of said lots, N. 78-47 E. 212 feet to an iron pin, crear corner of Lot No. 18; thence along the rear line of Lot No. 18, S. 2-00 W. 40 feet to an iron pin, new corner; thence a new line, along the middle of said lot, approximately S. 78-35 W. about 205 feet to an iron pin on the east side of Earle Street, new corner; thence along Earle Street, N. 4-03 W. 40 feet to the beginning corner.
