to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. HAROLD TOWNES and OTIS O. CORBIN, their heirs and assigns forever,

ALL that piece, parcel or lot of land, together with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northeastern side of Pleasantburg Drive (By-Pass S. C. Highway 291) and having, according to a plat thereof prepared by Madison H. Woodward in February 1958, the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Pleasantburg Drive (By-Pass S.C. Highway 291) at the corner of property of Greenville County School District No. 520 and the Eastern edge of the right-of-way of said highway and running thence along the line of the property of said School District, S. 77-10 E. 90.6 feet to an iron pin at the corner of property belonging to Byrd; thence along line of property belonging to Byrd, N. 21-04 E. 78.2 feet to an iron pin (also recited as N. 20-00 E. 78.2 feet); thence running along the line of property belonging to Marchant, N. 80-45 W. 89.3 feet (also recited as N. 80-33 W. 87.9 feet) to an iron pin on the Northeastern side of said Highway; thence along the edge of said Highway right-of-way, S22-50 W. 73.0 feet to the point of beginning.
