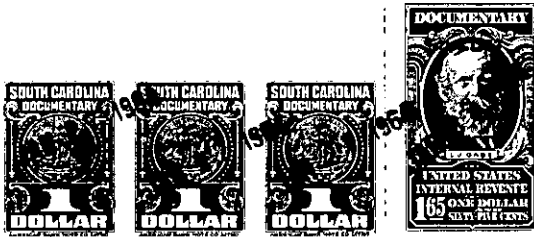
Know All Men by These Presents:

G. Landreth, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as lot No. 56 on a plat of Farmington Acres, recorded in the R.M.C. Office for Greenville County in plat book RR, page 106-7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Cherrylane Dr., at the joint front corner of lots 55 and 56 and running thence with the common line of said lots S. 37-15 E., 150 feet to an iron pin; thence N. 52-45 E., 90 feet to an iron pin; thence N. 37-15 W., 150 feet to an iron pin on the southeasterly side of Cherrylane Drive; thence with said Drive S. 52-45 W., 90 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Farmington Acres and to the set back line as shown on said plat.
