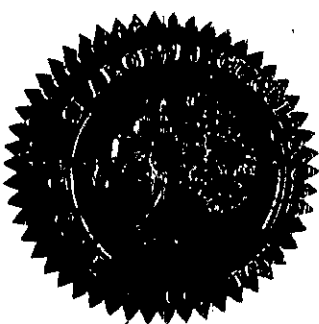
all that piece, parcel or lot of land in Ghatt Township, Greenville
