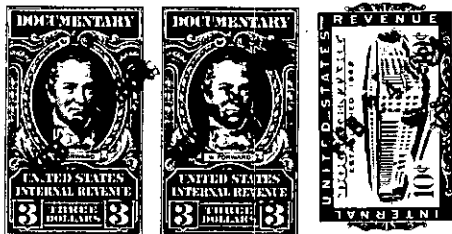
KNOW ALL MEN BY THESE PRESENTS, that We, CHARLES E. FINLEY and IRMA D. FINLEY,
