the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto
D. L. Phillips, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #11 of a subdivision known as Welcome Acres, as shown on a plat thereof prepared by Piedmont Engineering Service, dated July 1963, recorded in the R. M. C. Office for Greenville County in Plat Book DDD, at Page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Cole Road, joint front corner lots #11 and #10, running thence along the joint line of these lots, S. 72-02 W. 224.4 feet to an iron pin on an easement; thence along said 20 ft. easement, N. 8-0 E. 163.2 feet to an iron pin at joint rear corner lots #11 and #12; thence S. 81-30 E. 187.1 feet to an iron pin on the western side of Cole Road; thence along the western side of Cole Road, which line is curved, the chord of which is S. 5-0 E. 65.0 feet to an iron pin, point of beginning.
