

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Robert L. Watkins, Jr., his heirs and assigns forever,

All those pieces, parcels or lots of land in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated on a plat of Pleasant Valley Subdivision by Dalton & Neves, Engineers, April 1946, with revisions and additions, and recorded in the R.M.C. office for Greenville County in Plat Book BB at page 163, reference to which is hereby made and described as follows:

- 1. Lots 57, 81, 82, 284, 285, 293, 348, 349, 350, 351, 352, 353, 354, 414, 415, 416, 417, 418, 419, 420, 95, 84.
- 2. That portion of said subdivision bounded by Palmyra Avenue, the southern side of Pleasant Ridge Avenue, and extension of the southern side of Potomac Avenue, and the western boundary line of said subdivision.
- A triangular portion of said subdivision bounded by Plaza Avenue, the northern line of Lot 420, and the western boundary of said subdivision.
- That portion of said subdivision bounded on the southeast by Penrose Avenue and on the northwest of Northwestern property line of said subdivision.
- 5. The land occupied by any streets or roadways shown on the aforementioned plat which have not been previously conveyed to Greenville County or the City of Greenville.

This conveyance is made subject to protective covenants recorded in the R.M.C. office for Greenville County in Deed Book 301 at page 60 and in Deed Book 367 at page 106 and is subject to such easements and rights of way as have heretofore been granted to or acquired by the Greater Greenville Sewer District Commission and the South Carolina Highway Department.

The above described land includes that triangular portion of land bounded on the east by Lot 355 and on the north by Pacific Avenue and on the west by the rear lines of Lots 349 through 354, inclusive.
